



Health & Safety Plan

To promote the safety of everyone attending ASD 2022, we will monitor the guidance and requirements of the [Centers for Disease Control \(CDC\)](#), [State of California](#), the [California Department of Public Health](#), and the [World Health Organization \(WHO\)](#) regarding COVID-19 safety practices. In addition, [the City of San Francisco has additional requirements](#). Therefore, this Attendee Safety Plan may change from time to time through the last day of ASD in April 2022.

The Westin St. Francis on Union Square has implemented a [variety of new protocols and elevated practices](#), in response to the COVID-19 pandemic and keeping with our high standards of cleanliness and commitment to providing excellent service. They have also made a few adjustments to the services, amenities, and facilities available during your stay.

Please note that effective July 27, 2021, the CDC is now advising those vaccinated (either fully or partially) to wear facemasks while indoors in public. As a result, ASD is requiring all at ASD 2022 to wear a face mask while in the Westin St. Francis on Union Square or while attending all ASD-hosted events or meetings.

IMPORTANT: In light of events surrounding COVID-19, this is an appropriate time to remind ourselves of the risks incident to attending ASD 2022. Even with every reasonable precaution to keep you safe as outlined for you by the CDC, ASD cannot fully eliminate all risks of harm to attendees or guarantee their safety, especially from risks posed by COVID-19 or its variant strains. **Ultimately, you are responsible for your own safety.**

Deciding to Attend:

- Anyone having underlying COVID-19-related risk factors should not attend.
- Anyone exhibiting any symptoms or signs of sickness or who has been in contact with known positive COVID-19 cases should not attend.
- Anyone testing positive for COVID-19 within the last 14 days from the start of ASD 2022 should not attend.
- Anyone who refuses to meet the requirements listed below should not attend.

WHAT WE ARE DOING FOR YOUR SAFETY:

REQUIREMENTS:

- **Proof of Vaccination:** In San Francisco you may need to show proof that you have been vaccinated to go indoors in some places, like: bars, restaurants, clubs, gyms, large indoor events, and any business or event serving food or drinks indoors. [Read more](#). The vaccine card (physical or image) must show both the first and second dose of Pfizer/BioNTech or Moderna vaccines or the single-dose Johnson & Johnson vaccine. Vaccines approved by the [World Health Organization \(WHO\)](#) will also be accepted.
- **Face Masks Must be Worn:** An [acceptable mask](#) is made of at least two layers of breathable fabric or hospital grade material; fully covers the nose, nostrils, and mouth; fits firmly under the chin; and fits snugly, but comfortably against the side of the face.
- **Social Distancing:** Be mindful of the social distancing protocols and compliant with all posted instructions and signage.
- **Emergency Contact Number:** All attendees are required to provide a working mobile phone number to AVS and emergency contact at the time of registration in case ASD is notified by any government or local health department that contact tracing is required.
- **Waiver Form:** All Registrants are required to Review and accept the *ASD/AVS Assumption of the Risk and Waiver of Liability* statement prior to registering.

ASD AND AVS ASSUMPTION OF RISK AND WAIVER OF LIABILITY:

ASD and AVS Assumption of Risk and Waiver of Liability Statement: By checking the “I Accept” button below, I, on my behalf and on behalf of each individual included in this registration (“Registrant”), acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that we may be exposed to or infected by COVID-19 by accessing the 6th Area Selective Deposition Workshop (ASD 2022) (“Event”) in-person and that such exposure or infection may result in personal injury, illness, permanent disability, and death. As such, I accept the terms of this Assumption of the Risk and Waiver of Liability. Registrants understand that the risk of becoming exposed to or infected by COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the American Vacuum Society, the Westin St. Francis San Francisco on Union Square their respective employees, agents, contractors, volunteers, and other Event participants. Registrants agree to abide by [all preventative measures \(collectively “Measures”\)](#) put in place by ASD and AVS, the Westin St. Francis San Francisco on Union Square, their respective employees, agents, contractors, and volunteers at any time prior to and during the Event including, but not limited to, [being prepared to show proof of vaccination where required](#), wearing an [acceptable mask](#) at all times in public spaces, remaining at least six feet away from other Event participants, and promptly notifying AVS if any registrant experiences symptoms of COVID-19 during the Event. Registrants acknowledge that personal failure to follow these measures may result in being removed from the Event and all related activities without any refund or reimbursement. Finally, Registrants acknowledge that no promises, representations, or affirmations of fact were made to me concerning the safety or danger associated with traveling to the Event or participating in any activity or interaction related to or associated with the Event.

ENTRY & SYMPTOM EVALUATIONS:

- Signage will appear at any entrance alerting attendees that entry will be denied if they have:
 - been diagnosed with COVID-19 in the last fourteen (14) days,
 - exhibited symptoms of COVID-19 in the last fourteen (14) days, or
 - had contact with a person that has or is suspected of having COVID-19 within the past fourteen (14) days and have not completed a quarantine protocol, or
 - not provided proof of vaccination
 - refused to wear a mask at entry or while in the Westin St. Francis on Union Square or any facility hosting an ASD-hosted event or meeting.
 - Attendees must adhere to the requirements of any such signage and any directives from ASD staff given onsite during the event. Failure to do so could result in the denial of entry or removal from the venue altogether without refund
- **ASD reserves the right to deny such entry to anyone seeking admittance or to remove them from the venue should they present with any COVID-19 like symptoms or refuse to wear a mask while indoors whether vaccinated or not. No refunds will be given, and such conduct may disqualify such individuals from attending future ASD Meetings.**

ISOLATION AREA:

- There will be a designated isolation area for individuals experiencing COVID-19-like symptoms at registration. You will be asked to remain in this area until you have secured an appointment with a testing facility, at which time you will be directed out of the building.
- ASD will assist those presenting COVID-19-like symptoms to exit safely.
- A negative COVID-19 test must be presented at the Registration Desk for consideration to re-enter. Upon review, you may be granted approval to return to the meeting. [Click here for a list of nearby testing sites.](#)

In addition, ASD will be implementing the following safety measures in addition to the enhanced Westin St. Francis on Union Square cleaning protocols in each meeting area:

ALL AREAS:

- Handshaking, hugging, or other unnecessary person-to-person contact will be discouraged between all participants.
- ASD will remind participants through appropriate signage and/or verbal communications.

REGISTRATION AREA:

- Pre-registration encouraged in order to minimize lines in Registration Area
- Limited Conference handouts or material bins

SESSION ROOMS:

- Sanitizing kits in every session room
- Presentation Area sanitizing wipe-down between presenters
- Socially distanced seating where feasible
- Hand sanitizer stations in session hallways/entryways

POSTERS/RECEPTIONS:

- Socially distanced layout where feasible
- Hand sanitizer stations throughout the room.
- Additional F&B stations with more pre-packaged options where feasible

OTHER GUIDELINES:

TRAVELING TO ATTEND:

- **San Francisco Vaccine Requirements:** In San Francisco you may need to show proof that you have been vaccinated to go indoors in some places, like: bars, restaurants, clubs, gyms, large indoor events, and any business or event serving food or drinks indoors. - **Airline Policies:** Check with your airline to make sure you understand their policies and requirements.
